


## 2014 ANNUAL REPORT

# ABOUT POWELL ECONOMIC PARTNERSHIP

Working with a wide variety of community partners, the Powell Economic Partnership (PEP) is focused on its mission to unite the business community and government to create wealth, jobs and improve the quality of life consistent with the culture and environment of the Powell Valley for the benefit of all citizens.

#### BUSINESS DEVELOPMENT

80-95% of job creation comes from existing businesses (AdyAdvantage) As outlined by the community, PEP's primary focus is on business development, which includes assisting current and new, or expanding, businesses, especially "Primary" employers. Primary employers are those companies that make and distribute a product or service and sell it out of the area, bringing in "new money". PEP's number one program is that of business retention and expansion. PEP strategically visits existing employers to learn more about their industry and share the many services that PEP offers or that are provided by its many partners – from financing to workforce training funds to market research. Local entrepreneurs will find PEP has additional services geared toward their unique needs including business plan review to financing options, mentorship, and a variety of other services. Finally, through strategic outreach and working with existing businesses, PEP broadcasts that Powell is "Open for Business."

#### AWARENESS & EDUCATION

Awareness of existing programs on the local, state and federal level are one of PEP's strengths. From the Small Business Administration to the Wyoming Business Council, United States Department of Agriculture Rural Development and other government and nonprofit offices, there are a significant number of resources that are constantly updating their rules and regulations.

#### COMMUNITY

Economic development cannot be successful without a strong community to support the local workforce and their families. PEP actively partners with the local governments and appropriate institutions to strengthen Powell's assets, including housing, healthcare, education and other issues that are paramount to our community's economic success.




#### RETURN ON INVESTMENT

One can argue that the return on investment for economic development is not just about job creation and the new dollars that a community might see. However, the most demanded and measurable impacts come in the form of jobs and numbers. Although PEP is a fledgling organization, hiring its first Executive Director just last year, the numbers below show the promise of future economic success in Powell.

Community Investment in PEP: \$304,069

Economic Impact: \$2,462,125\* Capital Investment: \$1,019,000\* Local Tax Revenue: \$48,4958\* State Tax Revenue: \$232,690\* Total Job Creation/Retention: 31\*

Annual Payroll (for 31 jobs): \$1,165,693\* Local Household Spending: \$1,048,613\* \*The economic statistics were calculated by a Regional Project Assessment System, an Economic and Revenue Impact Software, courtesy of the Wyoming Business Council. 
#### **Asset Analysis:**

PEP provided a forum for dialog specific to Northwest College with the Wyoming Business Council and Ady Voltedge consultants. The conversation emphasized Northwest College's role, current and potential, for our local employers and workforce development. Workforce continues to dominate most business visits and has gained in momentum throughout the County and is a topic at the State level as well.

## SUPPORTING & GROWING EXISTING BUSINESSES

In 2014, PEP leadership conducted visits with over 25 employers in the city. The purpose of these visits is to learn more about the individual business, introduce key partners that may provide a service to enhance the bottom line, and explore ways that PEP may serve the business, either through expansion or retention needs. The result of these visits lead to referrals to partnering organizations for the respective needs, including the University of Wyoming Market Research Center, Small Business Development Center, Wyoming Business Council, Procurement and Technical Assistance Center (government contracting), Workforce Services Workforce Development Training Fund, and Wyoming Smart Capital Network. Additionally, these visits result in opportunities for PEP to provide support and assistance for issues like zoning, through its Small Business Advocacy program.

In early fall of 2013, SWi, LLC (SWi) approached the Powell Economic Partnership, Inc. (PEP) to understand what possible options might be available to them. A recent restructuring had left them with no credit lines with their suppliers, but yet they had a season full of contracts in hand. Local traditional lenders were not willing to take on the risk, nor was there a match with a typical economic development financial tool.

PEP was able to connect SWi with an independent source of financing and SWi secured a bridge loan with this source to keep their operations going through the summer.

SWi is now self-sustaining and has completely paid off their bridge note. This PEP connection helped save 13 well-paying jobs in the Powell area. Economic analysis of the project shows retention of 13 direct and 4 indirect jobs for a total payroll of \$837,000.

#### SMALL BUSINESS ADVOCACY

Enhancing communication between a business and the City and/or another agency can often lead to growth and expansion, job creation and even actual dollars saved. In fact, two of PEP's successes for this report are a direct result of advocating for zoning changes in Gateway West Business Park.



One Stop Motorsports outfits and services many of Powell's outdoor recreation needs from their new location in Gateway Park. Their expanded showroom will allow for more product lines in the future as well.

#### **GATEWAY PARK**

PEP Board of Directors listened and responded to the needs of two local businesses that were seriously considering Gateway Business Park, but were facing zoning ordinances that did not seem to allow for their respective businesses.

#### ONE STOP MOTORSPORTS

One Stop Motorsports was looking to enhance their existing business on the South Side of town and move it to Gateway, building a beautiful new building to showcase their product and expand their full-service capacity for atv and motorcycles. They had identified Gateway Business Park as their ideal location to grow their business, but were facing a challenge from the planning & zoning commission.

Specialty Tool & Attachment was operating successfully out of their home-base, but wanted to move their business to town and give it better exposure and more opportunities for growth and success. They too were facing similar issues to One Stop Motorsports regarding the allowed uses by the zoning ordinances.

PEP board members led the charge, actively supporting the businesses in their appearance before the City of Powell Planning & Zoning Commission, and ultimately City Council. They received a variance which allowed them to begin construction. Both businesses are now open for business in their respective locations!


#### ENTREPRENEURSHIP & STARTUP

#### Financial Economic Development Tools Series

As part of our Access to Capital program and Partnerships program, PEP hosts a series on various Financial Economic **Development Tools** available on a local, state and federal level for our local finance community, including accountants and lenders. Guests have included the SBA504 Frontier group, Wyoming Business Council Challenge Loan Program and the USDA.

#### ACCESS TO CAPITAL

Access to Capital is one of the most popular needs of any entrepreneur, especially a startup. PEP works with the local commercial lending community to help make good projects happen. Businesses in Powell have access to a number of resources, and PEP is helping to expand this list of resources and the awareness surrounding the many different programs.

#### CROWDFUNDING

PEP was awarded an opportunity to pilot a crowdfunding initiative for Powell through The Local Crowd, LLC to bring education and awareness to our community. Crowdfunding is a form of raising capital through the internet and social media. The value of this award was over \$25,000 for the education opportunities that it brought, with two nationally recognized authors offering workshops on local investing and social media.

Two projects have gone forward to-date with crowdfunding initiatives. Positive Progressions launched first and raised over half of their \$2,000 goal for funding video equipment for their agency, while WYOld West Brewing Company recently closed their crowdfunding campaign at over 166% of their goal, raising \$13,000 online and an additional \$2,000 from cash and checks.

## PARTNERSHIPS FOR ECONOMIC & COMMUNITY DEVELOPMENT

An economic development strategic plan for the City of Powell was long overdue. PEP took the lead to initiate a community-driven strategic plan. Over 1,300 volunteer hours were invested and in December of 2014, the Powell City Council formally adopted the Powell Economic Development Strategic Plan.

#### POWELL HEALTH NETWORK

As a result of the strategic planning process, the Powell Health Network was established. It is a grassroots venture of Powell health and wellness advocates. This initiative has been led by Dr. Betsy Spomer who has brought together an engaged and amazing group of professionals to develop a mission, vision and values for this volunteer organization.

Powell Health Network's mission is to promote, improve, and sustain community health and wellness through communication and collaboration. The vision is coordinated high quality health and wellness resources which optimally serve the needs of our community.

#### Powell Health Network Values are:

- 1. Encouragement and support for current health and wellness business and providers
- 2. Identification of and focused attention to gaps in locally available health and wellness services and resources
- 3. Collaboration and proactive communication to address community health and wellness needs
- 4. Clear communication with our community regarding the services and resources that are available locally
- 5. High quality health and wellness service and expertise, encouraging Evidence Based practice & Best Practice methods
- 6. Intentional provision and coordination of comprehensive care for Powell residents, both locally and via regional referrals as necessary

## LOW INCOME HOUSING PROJECT

In 2013, PEP teamed up with the City of Powell and Powell, Inc to help make two, low-income housing projects a reality for local citizens. A housing study done by the Wyoming Housing Authority showed the need for more affordable housing. PEP worked closely with the two developers, Summit Housing and Blueline and tried to bring some of our local contractors into the fold. Although no local General Contractors bid on the projects, there were several local and regional sub-contractors involved including AC Electric, Bloedorn Lumber, Dash Enterprises, and an additional 9 businesses from the region.

Funds received through lease payments from the Expansion project have enabled the city to partner with PEP and assist with contributing to PEP's budget and hiring of a full-time director. Funds additionally add to the City's Economic Development Fund for use by future businesses.


## KEEPING ECONOMIC DEVELOPMENT DECISIONS IN OUR COMMUNITY


